Regulation for World Photography Day Giveaway - Amoreiras 360° Panoramic View

1) Description

The purpose of this regulation is to govern the organisation, operation and use of the "World Photography Day" giveaway at Amoreiras 360° Panoramic View. By participating, users accept the Terms and Conditions outlined in this regulation.

2) Participants

Eligible to participate in this giveaway are all individuals residing and non-residing in mainland Portugal who are 18 (eighteen) years of age or older, who acknowledge and accept all the points of these rules, and who have an Instagram account. Employees and shopkeepers of stores in the Amoreiras Shopping Center, employees of the Amoreiras 360° Panoramic View, as well as collaborators of Mundicenter and the Instanta Fotografia store, are not allowed to participate in this giveaway.

3) Duration

The giveaway runs from July 10 to August 10, 2025, until 11:59 pm.

5) Participation Conditions

To participate in the giveaway, interested individuals must:

- 1. Follow the Instagram profile of Amoreiras 360° Panoramic View (https://www.instagram.com/amoreiras360view/);
- 2. Follow the Instagram profile of Instanta Fotografia (https://www.instagram.com/instanta.pt/);

- 3. Send a private message via Instagram to the @instanta.pt page, including your first and last name and email address, and Citizen Card number, to receive a free ticket for entry to Amoreiras 360° Panoramic View;
- 4. Collect the invitation for free access to the viewpoint at the Instanta Fotografia store in Amoreiras Shopping Center after registration validation and upon presenting the corresponding Citizen Card or Identity Card used;
- 5. Visit the Amoreiras 360° Panoramic View to take the photo to be used for the giveaway entry, during the current operating hours and subject to availability. The operating hours of the viewpoint can be consulted at https://www.amoreiras360view.com/pt/bilhetes/10;
- 6. Post the giveaway photo on your Instagram profile, tagging the @amoreiras360view Instagram page in the photo and including the giveaway hashtag: #360viewinstanta in the description;
- 7. Entries from public profiles will be accepted, or alternatively, from private profiles that submit their entry through this form;
- 8. The giveaway theme is open, with the only requirement being that the giveaway photo must be taken at Amoreiras 360° Panoramic View;
- 9. Participants can post as many photos as they want, but the ticket is valid for only one ascent to the viewpoint;
- 10. Using a photo that was taken or published before the giveaway start date is not allowed:
- 11. The entry ticket to the viewpoint is personal and non-transferable and cannot be given to another person, nor can it be exchanged (for cash, voucher value, or other items).

Participants in this giveaway are required to comply with the provisions of these rules.

Amoreiras 360° Panoramic View and Instanta Fotografia reserve the right to publish all entries (photographs) across all channels of the brands' universe, identifying the respective authors through tagging (@username).

6) Method of awarding the prize through a jury

All entries during this giveaway, which fully and simultaneously meet all the requirements established in the aforementioned section, will be considered in the evaluation by the jury.

The jury of the giveaway will consist of three members: two representatives from Amoreiras 360° Panoramic View and one representative from Instanta Fotografia.

The decisions of the jury are final and cannot be appealed.

After the end of the giveaway, the jury will select, from among all valid entries, the 3 entries that best reflect the concept of the giveaway and meet the requirements indicated in section 5.

The criteria for selection by the jury will be the originality and creativity of the entry. The 3 most original and creative photographs will be awarded.

The 3 winning photographs will be selected by a jury by August 16th.

The winners will be announced through a comment on the giveaway post on August 19th.

7) Prize Delivery

The winners will be contacted via private message on Instagram to provide the requested information (name, Citizen Card number, and email) within 24 hours of receiving the private message announcing them as the winner. Failure to provide this information within this period will result in automatic forfeiture of the prize, and another winner will be selected.

The prizes are personal and non-transferable. They cannot be converted into cash or exchanged for other products.

Winners must collect their prizes at the Instanta Fotografia store in Amoreiras Shopping Center within 30 days after being contacted, with an appointment scheduled with the store.

Presentation of the Identity Card or Citizen Card is mandatory for prize collection, and the document holder must be present for this purpose.

In case the winner is unable to collect the prize within 30 days after being contacted, Amoreiras 360° Panoramic View and Instanta reserve the right to declare the prize as not awarded. There will be no compensation for the winner, nor will there be a new selection process for another winner.

9) Personal Data Protection

1.
